OFFICIAL RULES

- This promotion is open to all Crescent Club members, 21 years of age and older with a valid photo ID.

HOW TO PARTICIPATE

- Crescent Club members may visit any Crescent Club kiosk during the promotional times listed below to reveal a Mystery Point Multiplier:
 - 8:00 AM – 11:59 AM on Thursday, March 5, 12, 19 and 26, 2026.
 - 10:00 PM – 1:59 AM on Thursday/Friday, March 5-6, 12-13, 19-20 and 26-27, 2026.
- Guests must swipe their Crescent Club card at any Crescent Club kiosk during each eligible session to activate the point multiplier.
- The Mystery Point Multiplier amount revealed at the Crescent Club kiosk will apply to qualifying base points earned during the same session only. A session is defined as the specific promotional time window in which the guest swipes their Crescent Club card at any Crescent Club kiosk and activates a Mystery Point Multiplier. Example: A guest who reveals a multiplier between 8:00 AM and 11:59 AM will receive that multiplier on qualifying base points earned between 8:00 AM and 11:59 AM that same day.
- To receive a Mystery Point Multiplier for any other scheduled session throughout the promotional period a guest must swipe their Crescent Club card at any Crescent Club kiosk for that session. Mystery Point Multipliers do not apply to any session other than the session in which it was revealed at a Crescent Club kiosk and will reset upon the conclusion of each session.
- Guests must visit any Crescent Club kiosk to activate a Mystery Point Multiplier each session throughout the promotional period.
- Mystery point multiplier amounts available to be awarded are as follows: 2X, 3X, 5X, 6X, 7X, 8X, 10X and 77X.
- Limit one (1) game play per guest per session. Multiplied points may not be visible on a guest's Crescent Club account for up to 24 hours.
