### **OFFICIAL RULES**

• This promotion is open to all Crescent Club members, 21 years of age and older with a valid photo ID, membership is free.

#### ANNIVERSARY DRAWINGS

#### **Earning Entries**

- Crescent Club members receive one (1) free entry and may accumulate one (1) additional entry for every ten (10) base points earned in game play.
- Entries may be earned beginning at 12:00 AM on Monday, October 20, 2025 through 11:00 PM on Saturday, November 29, 2025.

#### **Drawings**
