OFFICIAL RULES

HOW TO PLAY

Step 1 – Become a Crescent Club member & Register to Play

- All Crescent Club members receive one (1) free pick each week
- Register and play at snocasino.com from anywhere on your personal mobile device or desktop beginning September 8, 2026

Step 2 – Activate Your Weekly Picks

- Visit any Crescent Club kiosk Tuesday – Saturday each week to activate your free weekly pick

Step 3 – Make Picks

- Select the teams you choose to win each game or select 'Quick Picks' to have your picks made at 'random'

Step 4 – Check your Scores

- Rankings are updated each Tuesday – check to see if you've won!

BONUS PICK RUSH | SEPTEMBER 1 - SEPTEMBER 5

- All Crescent Club members may earn one (1) additional weekly pick submissions, in addition to their one (1) free weekly pick submission, valid for all eighteen (18) weeks of the regular season, by earning five-hundred (500) base points in slot and Table Games play or by placing a wager using the Snoqualmie Casino & Hotel Sportsbook mobile app of \$500 or more between 12:00 AM on Tuesday, September 1, 2026 and 11:59 PM on Saturday, September 5, 2026.

- Additional weekly pick entries may be earned or awarded through special promotional offers throughout the promotion.
- Each week of the eighteen (18) weeks during the promotion a predetermined number of 2026-2027 National Football League regular season games occurring only on Sunday and the early Monday Night game of each week that start at 1:00 PM Eastern Time on Sunday or later will be included in the prediction pool for that week for a total of 265 eligible regular season games.
- The NFL uses “Flex Scheduling” in the latter part of the season. This can cause some games that were originally scheduled for Sunday to be played on alternate days. If a game that was originally scheduled for a Sunday is moved to an alternate date, it may still count as a Sunday game for Pick’em Cards.
- In the case of a “Flex Schedule” game change, we reserve the right to close the Pick’em card submission dates as needed.
- Each week participants will be prompted to select their picks and choose a tie-breaker score to complete their entry. Tie-breaker scores are the total combined score of both teams of the early Monday Night football game or other designated game. Participants have the option to choose to have their picks selected at random or picking all the ‘Quick Picks’ option on the selection screen.
- Weekly pick entries may be submitted no earlier than 12:00 AM PT each Tuesday and no later than 11:59 PM PT each Saturday.
- Once a participant selects to submit their weekly entry that entry is final, it is the sole responsibility of the participant to verify the accuracy of their picks prior to submission.
- In the event that any participant submits multiple weekly pick submissions, only their best performing submission will be counted and displayed on the leaderboards.
